The MTA Roof Section Work Area measurers: 727 meters², 7824 feet², 0.18 acres 0.000 miles², 0.001km²

The following description of work is needed:

1. Demo the existing metal tile roof and remove from site
2. Install a layer of ice & water shield underlayment over the existing wood deck
3. Install new Berridge 25-gauge Spanish Metal Tile in a 20-year Kynar 500 Paint finish
4. All fasteners, sealants, and accessories
5. Demo the existing modified bitumen roof in the valley areas and remove from site
6. Adhere the 60 mil TPO membrane with low rise foam over the existing concrete decks
7. Warranty
